## ORDINANCE NAMING AN UNNAMED PRIVATE ROAD IN FORSYTH COUNTY EXTENDING NORTHEAST OFF SALEM CHAPEL ROAD "SLEEPY HOLLOW ROAD"

WHEREAS, the Forsyth County Emergency Services Department and the City/County Planning staff recognize a need for and recommend that an unnamed private road extending northeast off Salem Chapel Road within the unincorporated area of Forsyth County, be named in compliance with the requirements of Section 20-7, entitled "Road Naming Standards," of the Forsyth County Code, in order to avoid problems locating and responding to citizens in emergency and non-emergency situations; and

WHEREAS, a majority of the property owners adjoining the private road to be named, agreed to the name "Sleepy Hollow Road" as a potential road name; and

WHEREAS, the proposed "Sleepy Hollow Road" name is not in conflict with any existing road name in Forsyth County and has been approved by E911 services to ensure that Emergency Services Agencies are able to quickly respond to the location; and

WHEREAS, pursuant to the provisions of N.C.G.S 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said unnamed private road, Forsyth County caused notice of the time, place, and subject matter of the public hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse, and in at least two public places in the township or municipality nearest the road location, and to be published in a newspaper of general circulation published in Forsyth County.

**NOW, THEREFORE, BE IT ORDAINED** by the Forsyth County Board of Commissioners, after posting and publishing notice and conducting a public hearing as required by law, that an unnamed private road in Forsyth County extending northeast off Salem Chapel Road, as further identified on the attached map, is hereby named "Sleepy Hollow Road".

BE IT FURTHER ORDAINED that after naming the unnamed private road in Forsyth County extending northeast off Salem Chapel Road "Sleepy Hollow Road," Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road.

**BE IT FURTHER ORDAINED** that this Ordinance shall become effective upon its adoption.






### **Petition to Name**


