Use equipment designed for cooling, along with appropriate methods, such as: uncovering, plaising food in thin portions, etc. CDI-Moved to walk in and uncovered.
- 54 6-303.11 Intensity-Lighting - C-REPEAT- Lights under hood measured up to 33 foot candles. Increase lighting to 50 foot candles in areas of food prep. Light bulbs have been changed to 100 watt. May need to add lighting to illuminate these areas.
