- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P Bacon and hot dogs in cold drawer 50-53F. Air temp of unit 55F. Potentially hazardous food shall be cold held at 41F or less. CDI. Items stocked 2 hours previously. Raw bacon cooked immediately to 165F. Hot dogs discarded. Do not use cold drawer unit until it has been repaired to maintain food temperatures of 41F or less.
- 41 3-304.12 In-Use Utensils, Between-Use Storage - C Ice scoops in ice bins stored with handles touchng ice. Store scoops with handles protruding out of ice.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repeat violation. Repair non working worktop cooler and non working cold drawer unit to maintain food temperatures or 41F or less. Alternatively, remove units from facility. Note:adequate storage available, as most food stored in freezer unit. Remove upside down crates from floors throughout facility as they hinder floor cleaning. Equipment shall be in good repair.
