- 33 3-501.13 Thawing - C - Raw chicken gizzards thawing in prep sink measured 30F. Running water for thawing measured 77F.  
 Potentially hazardous food shall be thawed at a water temperature of 70F or below, under refrigeration, as part of the cooking process, or in a microwave oven and immediately transferred to cooking equipment. Recommend thawing under refrigeration during summer season as it will be hard to maintain running water at 70F or below.
