WHEREAS the North Carolina Public Health Association's Dr. Ann Wolfe Mini Grants for Child Health and Infant Mortality provide an opportunity for local health departments to receive a grant to enhance or further support programs that address child health and infant mortality; and

WHEREAS the Forsyth County Public Health Department seeks to apply for and accept, if awarded, a grant of up to \$8,000, to enhance its current safe sleep program by purchasing additional safe sleep spaces, such as baby boxes and portable play yards, as well as increase education and awareness on safe sleep for infants.

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes submission of a grant application to the North Carolina Public Health Association, and the Chairman or County Manager and the Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, necessary documents to receive grant funds, if awarded, from the North Carolina Public Health Association, through a Dr. Ann Wolfe Mini Grant, to enhance or further support programs that address child health and infant mortality, subject to a pre-audit certificate thereon, by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
