## FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO FISCAL YEAR 2019-2020 BUDGET ORDINANCE

FROM: BUDGET & MANAGEMENT MEETING DATE: October 24, 2019

## **EXPLANATION:**

On May 23, 2019, the Forsyth County Board of Commissioners adopted a resolution authorizing execution of necessary documents to apply for and accept U.S. Department of Justice, Bureau of Justice Assistance, State Criminal Alien Assistance Program (SCAAP) funds.

On September 26, 2019, the Forsyth County Sheriff's Office was notified that the agency has been awarded 2019 State Criminal Alien Assistance Program (SCAAP) funds from the U.S. Department of Justice, Bureau of Justice, in the amount of \$108,568.

As per the Department of Justice Reauthorization Act of 2005 (Public Law 109-162, Title XI) SCAAP funds may only be used "for correctional purposes" listed in the award solicitation. Since the original award in 2010 and including the 2019 award, a total of \$876,560 has been received and \$447,851 has been expended.

The purpose of this Budget Ordinance Amendment is to appropriate the \$108,568 to the Sheriff's Office, Detention Facility Operations. As in previous years, the unspent balance at June 30, 2020, will be re-appropriated in the FY 2020-2021 budget.

BE IT ORDAINED BY THE FORSYTH COUNTY BOARD OF COMMISSIONERSTHAT THE FISCAL YEAR 2019-2020 BUDGET ORDINANCE IS HEREBY AMENDED AS FOLLOWS:
