RESOLUTION DECLARING THE FORSYTH COUNTY BOARD OF COMMISSIONERS' INTENT TO CLOSE BRIDAL WOOD DRIVE AND CALLING A PUBLIC HEARING ON THE MATTER

WHEREAS on July 27,2020, a Petition was filed with the Forsyth County Board of Commissioners on behalf of the Petitioner, Winston Scott Craver, Heritage Oaks Holdings, LLC, requesting to close Bridal Wood Drive, heretaniter described, which property is located in Forsyth County; and it appearing to the Forsyth County Board of Commissioners from the Petition that a public hearing should be held on the question of closing Bridal Wood Drive, pursuant to N.C.G.S. 153A-241;
