Potentially hazardous foods shall be cooled quickly. Use methods such as ice baths, uncovering foods or shallow pans to cool foods. CDI- PIC placed quinoa in ice bath and cooled to 41 degrees.
- 53 6-501.12 Cleaning Frequency and Restrictions- Repair peeling wall occuring in ceiling and wall near tea/ coffee station. All physical facilities shall be maintained in good repair and shall be cleaned as often as necessary to keep them clean and by methods that prevent contamination of food products.
