### **Voter Challenge Evidentiary Hearing**

Chairperson Durrah made the following statement. "A preliminary hearing was held on September 12, 2024 for a voter challenge, filed by Nancy Sieber, regarding the voter registration and residency of Amy Taylor North. At that hearing, the Forsyth County Board of Elections voted to advance the challenge to an evidentiary hearing due to affirmative proof of probable cause. If the county board determines there is probable cause that the voter is not properly registered, it must schedule a full evidentiary hearing to consider the challenge. A notice of today's hearing was sent to the voter, the challenger, and the county party chairs via first-class mail and by email."

Ms. Tylor North requested that her legal representative speak on her behalf. Ms. Taylor North's attorney presented her case and evidence for domicile at her registered residence.
